The Illinois Commerce Commission ("ICC," "Agency," or "State") requires the services of a consultant (Vendor) to conduct a management audit of Commonwealth Edison Company (ComEd) pursuant to Section 8-102 of the Illinois Public Utilities Act (Act) (220 ILCS 5) as required by the newly enacted Section 4-604(g) entered into a Deferred Prosecution Agreement (DPA) with the U.S. Attorney for the Northern District of Illinois for a felony offense and shall pay all the incurred expenses needed.

### Section IV - Good Faith Effort

Pursuant to Public Act 102-0662 which created 220 ILCS 5/4-604(g). The Commonwealth Edison Company management audit is now statutorily required since Commonwealth Edison Company entered into a Deferred Prosecution Agreement (DPA) with the U.S. Attorney for the Northern District of Illinois for a felony offense and shall pay all the incurred expenses needed. The Illinois Commerce Commission initiated this contract with Liberty Consulting Group, effective on 08/16/2022 and ends on 08/16/2023 for 370,992 dollars, with an up to two (2) year renewal clause. The Consulting Group contracted needs to provide services including engineering, financial, knowledge of utilities: Gas, Water, Electric, Audit services, Certified Public Accountant (CPA) Services, and management experience to conduct the continuing audit of Commonwealth Edison Company. All 370,992 dollars in the initial contract and all renewals are paid for by Com-Ed. Illinois Commerce Commission has placed a 20% BEP goal on this solicitation because we thought this could be reasonably met by vendors. To date, the subcontractor has full filled 18.713% of the BEP goal of 20%. The final 1.287% of this BEP goal will be met once Com-Ed submits this month's audit to, The Ascent Group Inc, the subcontractor, to finalize this year's contract. All parties included in this project; Liberty consulting Group, The Ascent Group Inc - the subcontractor, and the ICC takes their commitment to achieving BEP goals seriously. Not only with this contract and with its renewals, and in extending opportunities to the BEP community whenever and wherever possible. To that end, it is important to note that this contract is fully funded with Commonwealth Edison Company dollars - not state or federally funded dollars.

Describe in detail the impact to the State if this renewal is not approved.

Not renewing this contract will be out of compliance to the Pursuant Public Act 102-0662 which created 220 ILCS 5/4-604(g), pursuant to 220 ILCS 5/8-102. The management audit is statutorily required since ComEd entered into a Deferred Prosecution Agreement (DPA) with the U.S. Attorney for the Northern District of Illinois for a felony offense and shall pay all the incurred expenses needed.
