The Prime has utilized the subcontractor during the ongoing term to provide legal service on various assignments. The BEP spend is lower than the goal, however, the use of the subcontractor is dependent on the type of legal services required during the term. The Prime is used in the areas of contract management and dispute resolution which were of major focus during this term as it is critical to utilize a vendor who specializes in these areas and to continue to utilize them for continuity as an ongoing legal concern progresses. Moreover, in contract mediation, it is important that the lawyer utilized have historical reference to previous arguments made as objections and new arguments are made. The subcontractor was primarily used on legal services outside these particular areas. The BEP goal for this project is the highest BEP goal on a contract by the Lottery and exceeds the Agency CEI BEP goal that took effect in January of 2022 of 30%.

Describe in detail the impact to the State if this renewal is not approved.

If this renewal is not approved, then, the Lottery will have not have continuity with regard to legal services related to contract management and dispute resolution; With regard to dispute resolution, more specifically, the Lottery will not have adequate expertise in the area of contract mediation as it relates to present and, any future potential litigation. Moreover, the Lottery would lose a firm and associated lawyers who have assisted the Lottery in navigating disputes as well as historical reference to earlier arguments as they have been made. Finally, the Lottery will not have adequate resources to handle all important legal matters related to the Lottery.

Section V - Additional Information

If the vendor's actions alone do not fully explain the vendor's good faith effort, provide additional information explaining why the contract's current term BEP goal percentage was not achieved.

The Prime Vendor is working with the new BEP Compliance Monitor to provide supporting documentation. The use of the subcontractor is dependent on the legal area being reviewed and the Prime and Subcontractor's area of legal expertise and experience. The Prime Vendor is primarily used in the areas of contract management and dispute resolution which were of major focus during this term as it is critical to use lawyers experienced in resolving conflict who are able to communicate effectively with the versatility and adaptivity to respond to different scenarios and challenges. Moreover, in contract mediation is important that the lawyer utilized have historical reference to previous arguments made as objections and new arguments are made. These areas were within the wheelhouse and area of expertise of the Prime. The subcontractor was used on other projects outside these areas of focus but within their particular
