On behalf of the Department of Central Management Services and the Business Enterprise Council, we are proud to present the FY 2011 Annual Report of the Business Enterprise Program (BEP) for Females, Minorities, and Persons with Disabilities. During FY 2011, BEP vendors received \$274,339,716 or 37.55% of total contract dollars, subject to goal. This amount exceeded the statutory BEP goal of 20% by more than 17.55%. In addition, this year's contract totals reflect a 4% increase over FY 2010.

We remain steadfast and committed to the continued improvement of our performance. We continue to look for ways to enhance the Program by increasing outreach programs, streamlining our certification process, and continuing to encourage qualified, prospective vendors to seek State business.

EXECUTIVE SUMMARY

Introduction

Governor Pat Quinn is committed to helping small and diverse businesses grow and prosper by doing business with the State of Illinois. Under his leadership, Illinois has continued to increase access and opportunities for entrepreneurs through the Business Enterprise Program (BEP) and key procurement initiatives led by the Department of Central Management Services (CMS). BEP promotes economic development of businesses owned by minorities, females and persons with disabilities to the maximum extent possible within Illinois.

This Fiscal Year 2011 Annual Report submitted by the Business Enterprise Council for Minorities, Females and Persons with Disabilities (Council) pursuant to 30 ILCS 575/8f, highlights participation of agencies and universities spending in our Program . This report identifies the “universe” of dollars subject to the BEP goal and provides a breakdown of the goals attained for each agency and university as well as achievement levels by statutory demographic categories.

In reviewing this report, it is important to understand how CMS and the State arrived at these numbers. In FY11, CMS introduced new initiatives which helped pave the way for these results. CMS has updated its statewide purchasing system to allow for agencies to provide additional information on the opportunities for BEP vendors on particular solicitations. In addition, CMS encouraged State Agencies and Universities to look at all procurements for their appropriateness for utilization goals, increased efforts to educate agency purchasing officers about the program requirements and focused outreach efforts to inform diverse small businesses on the state’s purchasing requirements.

Historical Background

BEP was created in 1984 pursuant to the Business Enterprise for Minorities, Females and Persons with Disabilities Act (30 ILCS 575/1). It is the public policy of the State of Illinois to promote and encourage the continuing economic development of minority, females and persons with disabilities owned and operated businesses. The Act originally established a minimum overall participation goal of 10% that applied to the agencies and universities under the purview of the Office of the Governor, and this goal was subsequently raised to 20% in 2010. During FY11, the State of Illinois has set its highest goal in the history of the program, with the Council adopting a participation goal of 20% of the total dollar amount of state contracts subject to BEP goals. While we are proud of this landmark decision and our achievements, we recognize there is still more work we can accomplish to improve upon the program's activities and maximizing the benefits to the diverse business community.

Fiscal and Legislative Accomplishments

The increased BEP goal percentage of 20% has established a concentrated effort amongst all State agencies and universities, in striving to ensure BEP vendors participate to the maximum extent possible in its procurements. This effort has resulted in an achievement of \$274,339,716, representing 37.55% of contract dollars received by BEP companies. This dollar amount reflects an increase of \$11,647,447 or 6.86% from FY2010. Furthermore, 840 individual BEP vendors received a total of 4400 contracts, with an average contract amount of \$62,349.

During FY11, the BEP also established new grant procedures between the Department of Commerce and Economic Opportunity and the Capital Development Board. This effort, in response to Public Act 96-1064 which requires recipients of these grants to comply with the BEP Act requirements. Additionally, pursuant to Public Act 97-260, BEP is responsible for the oversight and administration of the newly created Veteran Business Program. This new component will complement the ongoing BEP activities, providing for participation opportunities for Veteran and Service Disabled Veteran-owned small businesses, to compete for 3% of state purchases subject to the statute.

In addition, the BEP designed a new programmatic element consistent with new legislation establishing the Veterans Business Program (VBP). This new component will complement the ongoing BEP activities, providing for participation opportunities for Veteran and Service Disabled Veteran-owned small businesses, to compete for 3% of state procurements.

Certification Accomplishments

Through streamlining efforts, BEP has successfully certified 1,895 companies by the close of FY11. We have been able to increase our vendor base through added Outreach recruitment efforts and enhancing our “vendor recognition” certifications through agreements with other state, municipal and local business associations. FY11 certification totals reflect an additional 222 firms or a 13% increase of certified entities being added to our BEP vendor base from FY10.

Outreach Efforts

BEP increased outreach efforts to diverse businesses with the first hosted CMS\Business Diversity Summit. In addition, we continue to work directly with added stakeholders such federal and State agencies, the Small Business Administration (SBA), the Illinois Procurement Technical Assistant Centers (PTAC), Small Development Centers (SBDC) and other assist agencies and chambers of commerce across the state. BEP has established an “open door” policy where program staff is available to assist prospective and current vendors with all aspects of doing business with the State. In addition, personal consultations and teleconferencing is available for persons with disabilities.

Outlook for Fiscal Year 2012

BEP will continue to expand its efforts in all areas of Compliance, Certification and Outreach. The program will also be expanding increased certification and contracting activities with the implementation of the Veteran Business Program for FY 2012.

The BEP Compliance division will establish new reporting policies that will better assist State agencies and Universities by increased frequency in monitoring all vendors engaged in contracting activities. This new policy requirement will provide for prime and subcontracting participation in an accurate, real-time reporting format which will allow for early BEP contract intervention prior to compliance issues being addressed near the end of a contract term. In addition, CMS will continue to increase efforts to incorporate industry best practices that will enhance the program.

Our Certification division is streamlining its approach of certifying potential vendors applying to the State for added business opportunities. We are seeking to extend certification terms to five years, with annual no-change renewals taking place until certification expiration. We are exploring the acceptance of *Recognition Certification* (established through memorandums of understanding with other agencies), to coincide with annual certification dates of CMS' BEP program activities versus agency dates to assist in longer Recognition terms, for BEP vendors accepted into our program. During FY12, we will establish an on-line certification application, providing for ease of application for new and existing vendors and will provide specific dates of expiration for certified vendors on our BEP Directory. This enhancement to our search directory will assist prime contractors and agencies in verifying eligibility of current BEP program participants at time of bid without delay thereby expediting contract review and awards.

BEP's efforts in Outreach will continue to increase diversity by intensify our approach in recruiting BEP participation into non-traditional areas of industry. BEP firms will also benefit from major revisions to our website allowing for more *user friendly* information

enhancing their search for new business opportunities, applying for certification or taking advantage of the variety of business training modules.

In summary, the State of Illinois Business Enterprise Program has diligently managed to achieve a 37.55% State spending goal in Fiscal Year 2011. Over 41% of those spends have been with firms grossing under \$1,000,000 annually. Our efforts will continue to strive in contributing toward the economic success of all businesses, gain better access to State procurements and in increasing their capabilities to remain competitive within their respective industries.

It should be noted that this FY 2011 report marks the first time we have accounted for our achievement measured against actual Dollars Subject to Goal, not the actual 20% goal defined by formula along with a separate analysis of DBE spends for the Illinois Department of Transportation and Illinois State Toll Way Authority. This methodology ensures our focus in clearly identifying actual BEP spending for our State. This effort by BEP will establish a more aggressive stance in evaluating a truer level of transparent state participation within the Program for reporting as we move forward.
