30 ILCS 575/7(3) Sec. 7 Exemptions and waivers subsection (3) states: "Waivers. Where a particular contract requires a contractor to meet a goal established pursuant to this Act, the contractor shall have the right to request a waiver from such requirements." The Council or its delegate "shall grant the waiver where the contractor demonstrates that there has been made a good faith effort to comply with the goals for participation by business owned by minorities, females and persons with disabilities." CMS will review Vendor's documented efforts consistent with the factors listed in Section A, below, and may also, where applicable, consider whether the ability of other bidders to meet the contract goal suggests that good faith efforts could have resulted in Vendor meeting the goal.

**A. A Waiver is Granted**

A waiver is hereby granted as a result of a determination that the Vendor made a good faith effort to contact BEP certified vendors to inquire as to their availability to participate as subcontractors in providing products and services under the contemplated contract.

In support of the granting of this waiver, a determination was made that vendor made good faith effort to (check all that apply):

1. Contact the Business Enterprise Bureau prior to need and requested referrals from the certified vendor list and from any other list maintained by the Bureau. In evaluating whether Vendor has made good faith efforts in utilizing a requested certified vendor list either from the Bureau or on its own efforts, the factors below may be considered were applicable:

  - X Making efforts to assist interested BEP certified vendors in obtaining lines of credit or insurance as required by the Agency/University. (6.1.6).
  - X Making efforts to assist interested BEP certified vendors in obtaining necessary equipment, supplies, materials, or related assistance or services. (6.1.7).
  - X Thoroughly investigating the capabilities of BEP certified vendors and not rejecting them as unqualified without documented reasons. The BEP certified vendor's memberships in specific groups, organizations, or associations and political or social affiliations are not legitimate causes for the rejection or non-solicitation of bids and proposals in the Vendor's efforts to meet the goal. (6.1.5).
2. Advertise in the Official State Newspaper or a local newspaper. When evaluating good faith efforts in advertising for the recruitment of interested BEP certified vendors, the following factor below may be considered where applicable:
- X Soliciting through all reasonable and available means (e.g., attendance at a vendor conference, advertising and/or written notices) the interest of BEP certified vendors that have the capability to perform the work of the contract. The Vendor must solicit this interest within sufficient time to allow the BEP

certified vendors to respond to the solicitation. The Vendor must determine with certainty if the BEP certified vendors are interested by taking appropriate steps to follow up initial solicitations and encourage them to submit a bid or proposal. The Vendor must provide interested BEP certified vendors with adequate information about the plans, specifications, and requirements of the contract in a timely manner to assist them in responding promptly to the solicitation. (6.1.1).

3. Contact appropriate organizations such as unions, contractor associations, and MBE, FBE, or PBE oriented organizations. When evaluating good faith efforts in the use of organizations, the factors below may be considered where applicable:

Effectively using the services of available minority/women community organizations; minority/women vendors' groups; local, state, and federal minority/women business assistance offices; and other organizations that provide assistance in the recruitment and placement of BEP certified vendors. (6.1.8).

4. Description of supporting information relied upon to make this determination:

This is a cure. On December 1, 2022, the BEP Compliance staff called the 3 BEP firms listed in NIGP Code 93872: Radio, Telecommunications, Telephone Equipment, Including 911 Systems and Facsimile Transceivers, Maintenance and Repair in an effort to confirm the bidding vendor's Good Faith Effort Contact Log. A follow-up email was sent to the vendors that did not respond to the phone call on December 1, 2022. The vendors were given a deadline date of December 8, 2022.

BEP Compliance believe the bidder's GFE log to be true and accurate. The waiver is hereby granted.

Notes:

Results of BEP Compliance good faith efforts outreach of BEP firms listed in NIGP Code 93972 are as follows:

1. **JM International, Sang Bok Lee:** The vendor confirmed he was not interested at this time.
2. **Diverse Technologies, Inc., Tony Henry:** The vendor did not return the call and did not respond to the email. The Microsoft Outlook E-mail Read Receipt was read on December 5, 2022.
3. **Chicago Voice and Data Authority Corp., Jeffrey Warren:** The vendor responded to the phone call and confirmed they received a call from the bidder and no agreement was reached. The vendor said he responded "no" to the bidder question when asked if their company was authorized by manufacturer.

## **B. A Waiver is Not Granted**
