#### ABOUT THE CHIEF PROCUREMENT OFFICERS

#### **Mission and Values**

State procurement strengthens Illinois' economy when it

To work with agencies and universities to meet their procurement needs while exercising independent authority, oversight, and approval designed to continuously improve the procurement process and ensure: compliance with law, fair treatment, diversity, integrity, transparency and value.

- ensures that small businesses have meaningful opportunities to sell their supplies and services to the State
- develops policies and practices that encourage agencies to buy from Illinois' small vendors

### **Meet the Chief Procurement Officers (CPO)**

Ellen Daley has been the CPO for General Services since July 2015. After a few years in private practice as an attorney, she worked as senior legal counsel and Director of Procurement Compliance at Chicago Public Schools. She entered state government as procurement counsel at the Department of Central Management Services. Ellen has more than 17 years of direct public procurement experience and holds the Certified Public Procurement Official and Certified Public Procurement Buyer designations.

**Bill Grunloh** has been the CPO for the Department of Transportation since July 2010. Bill has a unique perspective of construction procurement having been a partner for 30 years in his family's construction business and the Chief of Staff at the Department of Transportation and an Illinois State Representative. Bill holds the Certified Public Procurement Official and Certified Public Procurement Buyer designations.

Art Moore was appointed the CPO for the Capital Development Board in June 2017. While new to the position, Art is not new public procurement. Art was recently a Senior State Purchasing Officer in the General Services portfolio and the Agency Purchasing Officer for the Illinois Environmental Protection Agency before that. He is active in the Illinois Association of Public Procurement Officials and is serving a second term as its Treasurer. Art holds the Certified Public Procurement Official and Certified Public Procurement Buyer designations.

When the State procures from small businesses, a significant economic benefit occurs: taxpayer dollars remain in our towns and cities longer than when buying from out-of-state vendors.

The General Assembly enacted the Small Business Contracts Act (SBCA) 30 ILCS 503 recognizing that state contracts with Illinois' small business owners facilitates job creation and economic development. One of the most important ways that state government directly supports small business is through purchasing their products and services. The SBCA created the goal that the State award not less than 10% of the value of all contracts to small businesses.

On August 9, 2017, Public Act 100-43 repealed the Small Business Contracts and added it in its entirety as a newly created Section 45-90 of the Illinois Procurement Code. At the request of the chief procurement officers, the legislature added the counting of subcontracts with small businesses that result from state contracts towards the 10% goal. Allowing the counting of these subcontracts was important as it's a **better measure** of how well state procurement is impacting Illinois' small businesses. For example, a very large New York construction firm may win a road construction contract. From this award, the large firm subcontracts flagging, debris hauling, and fence installation services to three Small Business Set-Aside Program vendors. These subcontracts may now be counted towards the 10% goal.

Under Section 45-90 of the Procurement Code, the CPOs are responsible for reviewing and approving agency small business contracting compliance plans, monitoring agency progress, and reporting on their outcomes.

In Fiscal Year 2017, the State started the fiscal year without a budget for the second consecutive year. Road construction projects continued while the Capital Development Board's projects remained at a standstill and procurements for general supplies and services saw fewer bidders and higher prices. Because the Department of Transportation receives primarily federal funding, they were able to continue timely payments to vendors.

#### **CPO for CDB Small Business Contracting**

The Capital Development Board (CDB) has a long history of utilizing small business firms in the design and construction of the State's buildings. When one of the State's 8,400 properties requires repair or renovation, CDB manages the project. Many projects involve modernizing facilities to meet accessibility standards and protecting the lives and safety of Illinois residents by removing such environmental hazards as asbestos and lead.

The Chief Procurement Officer for the Capital Development Board (CPO-CDB) has never exercised authority to set-aside contracts for small businesses since CDB's percentage of contracting with small businesses continually exceeds the 10% statewide goal.

CDB and the CPO-CDB routinely measure the overall pool of prequalified vendors, as well as those who receive contracts, to evaluate the need for a set-aside program. Nearly all of the CDB's contracts are awarded to vendors that are prequalified to bid by the CDB. In FY17, 64.5% of all CDB prequalified firms are small businesses. In FY17, 81 contracts representing 70% of CDB contracts awarded were awarded to small businesses.

#### **CPO for CDB Small Business Contracting cont.**

Fiscal Year 2017 participation data indicates that:

- Most pregualified vendors are small businesses
- CDB awards most contracts to small businesses
- CDB exceeds small business participation goals

The CPO-CDB continues to monitor the value of contracts awarded to small business to evaluate the need for a set-aside program. The FY17 performance of 33.0% of total spend to small business is another strong performance for small business participation. These numbers include contracts, change orders, and modifications that were obligated within the fiscal year.

This participation level does not include the participation by subcontractors, most of which are small businesses. As a result, actual participation of small businesses is much larger than just the participation by prime contractors identified in this report.

The CPO-CDB and CDB recognize the vital role small businesses play in CDB projects at the subcontractor level and are excited to count them in future achievement numbers. The CPO-CDB is thankful for the legislative changes by the 100<sup>th</sup> General Assembly to allow subcontractor participation to be counted in overall small business participation measurement. Regardless of the method for delivering a project, vertical construction is largely performed through tiers of subcontractors and material suppliers, the majority of whom are likely to be small businesses.

The CPO-CDB has encouraged CDB to track and calculate the role small businesses play in CDB projects at the subcontractor level and we are happy to be able to include their efforts in future small business reports.

DOT's spend with small businesses in both construction and non-construction procurements was \$93,481,032

In terms of dollar amount awarded, the Department of Transportation's (DOT) small business contracting is the highest in the State. In FY17, DOT awarded \$93.5 million in construction and non-construction contracts to small businesses.

IDOT's Small Business Set-Aside Program started several years ago. The designated Small Business Set-Aside projects are identified in several places in the Transportation Procurement Bulletin. In accordance with Section 500/45-45 of the Illinois Procurement Code and the rules of the Department, only bids from qualified small businesses will be considered for award. The nature of road and bridge construction does not lend itself well to small contracts that would fit into the Small Business Set-Aside Program, so projects are unbundled to the greatest extent possible to increase available projects for these Lettings.

To encourage maximum competition, these Small Business Set-Asides are open bidding items. In accordance with the rules of the Department, prequalification is waived for these items. All bidders, including those correctly prequalified by the Department, are required to submit with the bids a Qualification and Equipment Inventory Certification Form. The form is included with the proposal and bidding documents.

Typically, the Department administers an average of seven (7) scheduled lettings per year with approximately seven (7) Small Business Set-Aside projects per each letting.

#### **CPO for General Services**

The CPO's Small Business Specialist assists each agency with an annual compliance plan demonstrating how the agency will progress towards obtaining the 10% small business contracting goal. The Small Business Specialist provides guidance and assistance in the development of the plans and monitors progress during the year.

In the General Services portfolio, the most important tool to assist state agencies increase their small business contracting is the CPO-GS' requirement to use small business **set-asides**. When a contract is set-aside, only qualified Illinois small businesses may compete for it. The CPO-GS has designated more than 600 commodity codes as set-aside for small business.

Individual, yet centrally coordinated, procurement planning is essential to increasing contracting with small business. The CPO-GS and her SBSP team focuses on strengthening and expanding their unique procurement services offered to Illinois' small business owners. In FY17, the CPO-GS supported the Toll Highway Authority's piloting of the state's first procurement with a small business goal, studied agency spend to identify new small business set-aside categories, and co-sponsored an event for veteran-owned small businesses in the construction trades to meet prime contractors so they may develop business relationships.
